Y Gweinidog Tai, Adfywio a Threftadaeth (Huw Lewis): Ers cyhoeddi fy mhapur heriau tai, rwyf wedi cyhoeddi ein cronda Troi Tai'n Gartrefi er mwyn medru troi eiddo gwag yn ôl yn gartrefi, ac rwyf hefyd wedi cyhoeddi £18.12 miliwn yn ychwanegol o grant tai cymdeithasol i gynyddu'r cyflenwad o gartrefi. Bydd mwy o wybodaeth yn fy Mhapur Gwyn tai a gyhoeddir y gwanwyn hwn.

Darpariaeth Tai

Huw Lewis: The UK Government's policies are having a significant effect on people and housing markets. I am concerned about welfare reform, and housing benefit changes. We are helping people to cope with the changes. We have announced additional funding for more affordable homes and to bring more empty homes into use.

More action will be set out in my housing White Paper due this spring.

Huw Lewis: Our Welsh housing quality standard has resulted in significant action to improve people's homes. NPT Homes anticipates spending £152 million in the Aberavon and Sandfields estate area by 2017. Under the group repair scheme, £6.6 million has been spent in Aberavon improving 424 private sector properties.
