Section 12, page 4, line 30, leave out 'This Act' and insert—

- '() Except for section 1(2)(*[paragraph to be inserted by amendment 1]*) of this Act, all provisions come into force at the end of the period of two months beginning on the day on which this Act receives Royal Assent.
- ( ) Section 1(2)(*[paragraph to be inserted by amendment 1]*).

- '[] When exercising a power of entry, an inspector may only examine, measure, test or take a sample from an animal that is found on the premises (in accordance with paragraph 9(b) or (e)) if they are suitably trained.'

Schedule, page 7, after line 38, insert –

'[ ] A person taken onto the premises in accordance with paragraph 8(a) may only –  
(a) examine, measure or test an animal that is found on the premises;  
(b) take a sample from an animal  
if they are a suitably trained.'

Atodlen, tudalen 7, ar ôl llinell 38, mewnosoder –

'[ ] Ni chaiff person yr eir ag ef i'r fangre yn unol â pharagraff 8(a) ond –  
(a) archwilio, mesur neu brofi anifail a ganfyddir yn y fangre;

Schedule, page 7, after line 38, insert –

'[ ] (1) A person is suitably trained for the purposes of this Schedule if they are a veterinary surgeon or a person listed in regulations made under this paragraph with an appropriate level of expertise in the health and welfare requirements of animals on the premises.  
(2) The Welsh Ministers must specify in regulations one or more categories of persons who are to be regarded as being suitably trained for the purposes of this Schedule.  
(3) Regulations made under this paragraph may make different provision for different animals.'

'[ ] (1) Mae person wedi'i hyfforddi'n addas at ddibenion yr Atodlen hon os yw'n filfeddyg neu'n berson a restrir yn y rheoliadau a wneir o dan y paragraff hwn a chanddo lefel briodol o arbenigedd mewn anghenion iechyd a lles anifeiliaid sydd yn y fangre.  
(2) Rhaid i Weinidogion Cymru bennu mewn rheoliadau un neu ragor o gategorïau o bersonau y'u hystyrir yn bersonau sydd wedi'u hyfforddi'n addas at ddibenion yr Atodlen hon.  
(3) Caiff rheoliadau a wneir o dan y paragraff hwn wneud darpariaeth wahanol ar gyfer anifeiliaid gwahanol.'
